The first Friday of the new quarter is traditionally the quarterly meeting. The executive committee will set up the nominating and voting procedures. By statute, the Annual Meeting is held the first Friday in August. Jim Michels will set the time for quarterly meetings.

Preparation of resolution for neutrality on the incorporation issue of Powers Lake. Paul DeMichele moved to have the district prepare a resolution of neutrality on the incorporation of Powers Lake issue. Seconded by Bob Laurine. Motion passed unanimously.

Paul moved to allocate funds up to \$2100. for a fence for Outlot One to protect our wetland. Seconded by Bob Laurine. Motion passed unanimously.

Citizen Judy Joss presented a poster for National Appreciation Week.
