2010 Chairperson's Letter

As you may know, this is the 25th Anniversary Year of the District of Powers Lake. We are taking this time to recognize those who have contributed so much to the formation and continuation of the District. The keystone of the DPL was and is "A Management Plan for Powers Lake" which was prepared jointly between the original board of commissioners and the Southeastern Wisconsin Regional Planning Commission. 
