

Due to COVID, Our Annual Meeting will be held on Friday August 7th @ 7:00 p.m. at the Randall Fire House #2 which is located at the corner of Hwy KD and Hwy F (Bassett Road). We will be practicing social distancing and following the state guidelines. We welcome your attendance and participation. Our Annual Meeting is the time when we pass our 2021 Annual Budget, elect Commissioners and tend to the other lake related business. This year the seat occupied by Jim Michels is open for election.

We continue to work closely with the Town and the Water Patrol and are pleased with the relationships and open lines of communication on all things related to Powers Lake. This is important since the Town of Randall is responsible for the ordinances and enforcement. We believe that having a good working relationship and open lines of communications are beneficial to all.

We continue to monitor and treat the lake for Aquatic Invasive Species (AIS, Eurasian Water Milfoil & Curly Leaf Pond Weed). This year we treated roughly 5 acres and are thankful for the success of the program and are cautiously optimistic for continued success. on our waterways, the District is doing all we can to raise awareness and educate boaters on Best Practices to help prevent the spread of AIS. In doing so, we are embarking on a new initiative. We hope to create a new Capital Fund. The purpose of this fund will be to update our signage at the launches and eventually provide a cleaning station for boats entering and leaving the lake.

The recent issues affecting Lake Geneva and the Starry Stonewort infestation provide a timely reminder of how fragile the lake ecosystem is and the economic impact involved in eradication. We are far better off spending our resources on education and the prevention of the spread of invasives. The costs to eradicate are enormous and we feel that spending more on education and providing a means for boaters to clean their boats before and after entering the lake is a good investment in the future of Powers Lake.

Please continue to be considerate and conscientious boaters and do no harm to the precious resource that is Powers Lake.

Enjoy the balance of your summer on the lake and we look forward to seeing you on August 7th.
