As we prepare to close out another successful year and look forward to continuing our efforts to be good stewards of Powers Lake, it is appropriate to summarize for you some of the efforts and initiatives of the DPL.

Our Annual Meeting will be held on Friday August 4<sup>th</sup> @ 7:00 at the Randall Town Hall and we welcome your input and participation.

Jim Michels is up for reelection and we are sincerely grateful for his continued support and dedication to the District. Jim has been serving on the Board since 1995 in various capacities and was past Chairman for most of the last 22 years. His experience and knowledge of all things relating to Powers Lake are an invaluable resource and one we should never take for granted.

I am equally grateful to all of the Board members and volunteers for their dedication and input this past year. It is only through the spirit of cooperation and dedication that the DPL is able to continue our Mission to preserve and protect Powers Lake for the next generation.

We recently put a concerted effort into updating our website and it is now up to date with all of the appropriate past meeting minutes and Agenda items. The District has installed an electronic water level monitoring device to electroni-

cally capture real time water levels. The Town of Randall continues to manually take weekly water level readings which are posted on our website. We will transition and rely solely on the electronic device once we are confident in the integrity of the data from new device and we will post to the website on a regular basis.

Our treatment regimen continues for invasive plant species (Eurasian Milfoil & Curly Leaf Pond Weed). This year we treated roughly 7 acres which is a far cry from the 70 acres we used to be challenged with. There are several factors involved, but the most important is that we all individually take care to make sure we do our part to not exacerbate the problem. 
Please join us on August 4<sup>th</sup>, we look forward to seeing you.
